

### Sangeet



# Details & Agreements

## **Wedding Confirmation**

When you are ready to confirm your wedding with Hilton Atlanta, we require the deposit along with a signed contract. You will have 14 days from the time the contract is received to sign and provide deposit and secure your date. Should we not receive your contract by such date as noted on your agreement, the hotel reserves the right to release the provisional booking without notice.

Guestrooms do not require a deposit. Reception and ceremony space rental requires a 25% deposit. Payment may be submitted via check or credit card.

## Deposit & Payment Schedule

Advance deposits are required during the course of planning your event. At the time of contract signing, your non-refundable deposit will be due. The non-refundable deposit will be 25% of your anticipated revenue. Six months prior to your first event date, 50% of your anticipated revenue will be due. Thirty (30) days prior to your first event date, your final remaining estimated balance will be due based on your estimated guest count, service charge, tax, and any outsourced rentals.

Ten (10) business days prior to your first scheduled event, your final guest guarantees will be due. Any remaining balance on the master account will be charged at that time. This will include your final guest counts and room reservations. We require a valid credit card authorization to be on file for any remaining charges. Any additional event balance will be settled up within 48 hours after check out.
